#### **RULES AND REGULATIONS**

**SECTIONS** 7 – 8 – 9

#### POULTRY - WATERFOWL - PIGEONS

### Please adhere to COVID safe key principles that apply to the Gatton Showgrounds and the Gatton Show.

- 1. Exhibits may be penned 1 day prior to judging. Please inform preferred day of penning on entry form.
- 2. No limit to the number of entries in any class until pens are filled.
- 3. A.O.V or A.V classes- state breed and A.O.C or A.C class- state colour clearly written on entry form. If there are 6 or more entries per breed or colour in A.O.V, A.V, A.O.C, or A.C a separate set of classes will be created.
- 4. Entries must be bonafide property of the exhibitor.
- 5. The chief stewards always have control of the exhibits.
- 6. The stewards take care but accepts NO responsibility for the welfare of the exhibits.
- 7. All entries are to be free from vermin, healthy and in show condition. The chief stewards have the right to ask any exhibitor to remove from the Pavilion any exhibit that does not comply with these regulations at the expense of the exhibitor.
- 8. The chief steward reserves the right to cancel any class or entry at any time without redress from any exhibitor.
- 9. All entries will be judged in classes entered by the exhibitor.
- 10. The judge need not award a prize unless they consider the exhibits merits it.
- 11. Presentation of trophies and sashes will be as close to 3pm as possible
- 12. Exhibits may not be unpenned or unstaged until after the presentation.
- 13. All carry boxes must be removed from the pavilion before judging commences and they are not to be returned to the pavilion until the chief stewards say it is time to unpen or unstage your exhibit.
- 14. \*EXHIBITORS PLEASE NOTE\* poultry and waterfowl only- all leg bands are to be removed from exhibits and pens before judging. Pigeons- should have the appropriate leg bands. No leg bands or incorrect leg bands could cost the exhibit an Award. The judge takes NO responsibility for disqualifications on these issues.
- 15. ENTRIES to be sent to chief steward of each section only. Entry fee must accompany entries, or the exhibitor runs the risk of having his or her entries denied.
- 16. Junior exhibitors must nominate under their own name to be able complete for the junior award. Age of exhibitor must be displayed on the entry form.
- 17. Cage birds: All cages to be fitted with drinkers and seed on the floor suitable for type of bird entered.
- 18. The show is conducted under the Constitution of The Gatton Show Society Inc. All or any appropriate regulations shall apply to all exhibitors.
