### **YOUNG JUDGES COMPITION** **Friday 19th July 2024 starting at 6.30 PM**

#### **CLASS 1**

A Young Judges Competition in the Stud Sheep Section will be conducted under the following Qld Ag Shows' rules.

- The Hormel slide must be used at all levels in the Young Judges Competition
- Competitors must be over **15 years and under 25 years of age** on the 1<sup>st</sup> May in the year of the State Final.
- Competitors **under 15 years age** will compete in the Junior Young Judges Competition
- Competitors are to be a resident in Queensland for at least 3 months prior to competing.
- In all competitions four exhibits numbered 1,2,3,4 are to be used.
- Entrants are to nominate with the Steward prior to the start of judging.

Prize money donated by Malcolm Downs Suffolk Stud, The Redmond Family. Ribbons will be awarded to the three place getters in each class plus prize money 1st \$50.00, 2nd \$25.00, 3rd \$15.00 (in each class). Vouchers donated by Gatton Auto Electrical. The winner of the senior class is eligible to compete in the Queensland State Final at the Toowoomba Royal Show 2025.

### **STUD SHEEP CLASSES** **Saturday 20th July 2024 starting at 8:30am**

#### **RULES**

- All breeders must supply a current Brucellosis Accredited Certificate.
- All sheep must be the bona fide property of a registered member of the Australian Stud Sheep Breeds Association and other Registered Sheep Breed Societies.
- All Sheep must have been Bred by the Exhibitor with the exception of school entries.
- All sheep must be free of external parasites.
- NLIS tags are required for all sheep.
- Entries will only be received subject to the right of judge and steward, the judge or steward may reject stock which they may consider are not of sufficient merit to compete or are the wrong age of classes in which they are entered.
- All sheep will be inspected prior to judging to ensure that they comply with the above regulations and conditions.
- All sheep must be accompanied by a fully completed NVD or Waybill.
- Entry cards which include tag numbers are to be completed and presented to the steward prior to judging.
